

Momentum Telecom Regulatory Fees and Surcharges

Below is a listing of fees and surcharges which may appear on your Momentum Telecom invoice, as applicable. Please note that not all fees and surcharges apply to all services. These fees and surcharges are subject to change.

Name	Description
Administrative Compliance Fee (for Voice Services and Data Communications Services)	The Administrative Compliance Fee is assessed by Momentum to recover internal costs incurred to implement and comply with applicable regulatory requirements. These costs, separate from those recovered through the Regulatory Cost Recovery Fee, include various account servicing, billing, collections, and administrative costs which the Company incurs for local, state, and federal governmental data gathering, record maintenance, reporting, and compliance. This fee is neither government mandated nor a tax.
FCC Regulatory Fee (for Voice Services and Data Communications Services)	The FCC Regulatory Fee is assessed by Momentum to recover the annual regulatory fees as mandated by Congress, pursuant to Section 9 of the Communications Act of 1934, as amended. Section 9 requires the Commission to collect regulatory fees to recover the regulatory costs associated with its enforcement, policy-making and rule-making, user information, and international activities.
Federal Universal Service Fund Surcharge (for Data Communications Services)	All companies that provide interstate telecommunications and Interconnected Voice-over Internet Protocol ("VoIP") services are required to contribute a percentage of the total amount billed to customers to the Federal Communications Commission ("FCC") Federal Universal Service Fund ("USF"). The fees collected are used by the FCC to promote universal

	access to telecommunications services in the United States. The amount that Momentum is required to contribute to the USF is set quarterly by the FCC. Momentum recovers this cost in the form of the Federal USF Surcharge charge, as allowed by the FCC.
Network Cost Recovery Fee (for Data Communications Services and Internet Services)	The Network Cost Recovery Fee is assessed by Momentum to recover certain charges incurred from third-party network providers, including regulatory fees. This fee is neither government mandated nor a tax.
Property Surcharge (for Data Communications Services and Internet Services)	The Property Surcharge is assessed by Momentum to recover certain property-related costs incurred directly or through charges from third-party network providers for property-related state and local taxes and other property-related costs including, without limitation, building access fees, property assessments, and other premises-related charges. This fee is neither government mandated nor a tax.
Regulatory Cost Recovery Fee (for Voice Services)	The Regulatory Cost Recovery Fee is assessed by Momentum to recover a portion of its costs incurred to comply with applicable regulatory requirements either directly or through charges from third-party network providers, including Federal Universal Service Fund charges, FCC Telecom Relay Service charges, and charges and costs related to other governmental programs, local franchise fees, right-of-way costs, state regulatory licenses/permits, and jurisdiction-specific charges. This fee is neither government mandated nor a tax.
E911 Service Fee (for Voice Services)	The E911 Service Fee is a per-line monthly surcharge that is separate from the E911 tax paid to local 911 authorities. It is retained by the company to defray a portion of the costs of maintaining connections to 911 services and complying with government regulations associated with emergency calling.
